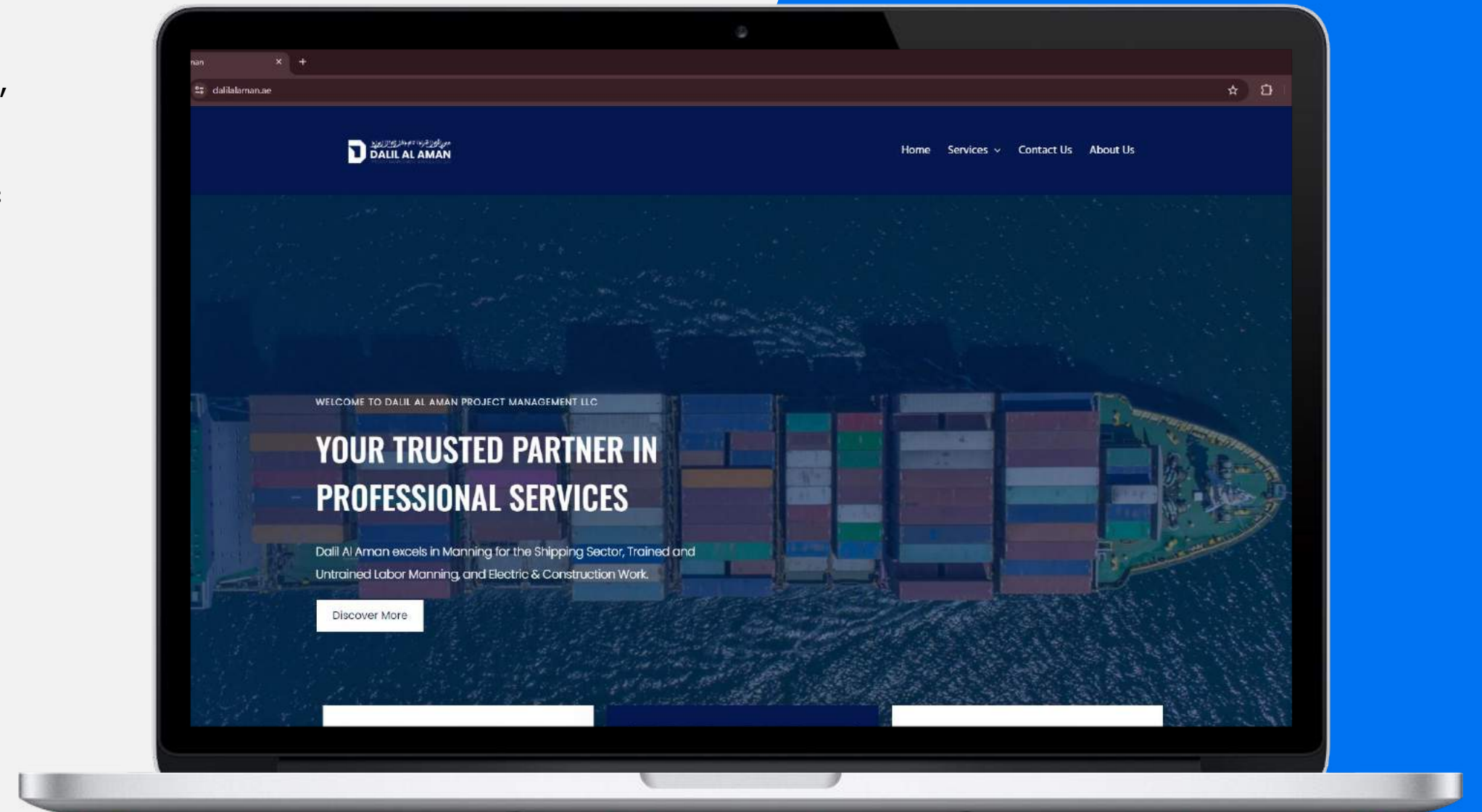

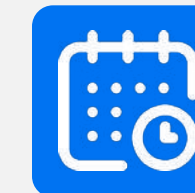
Financial Control and Decision-Making

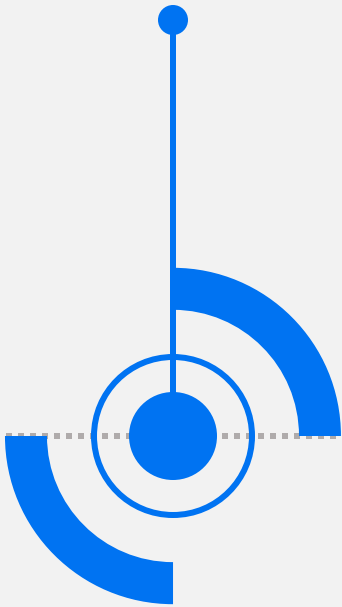

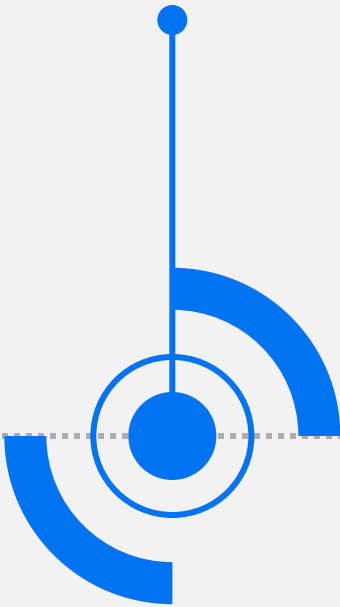

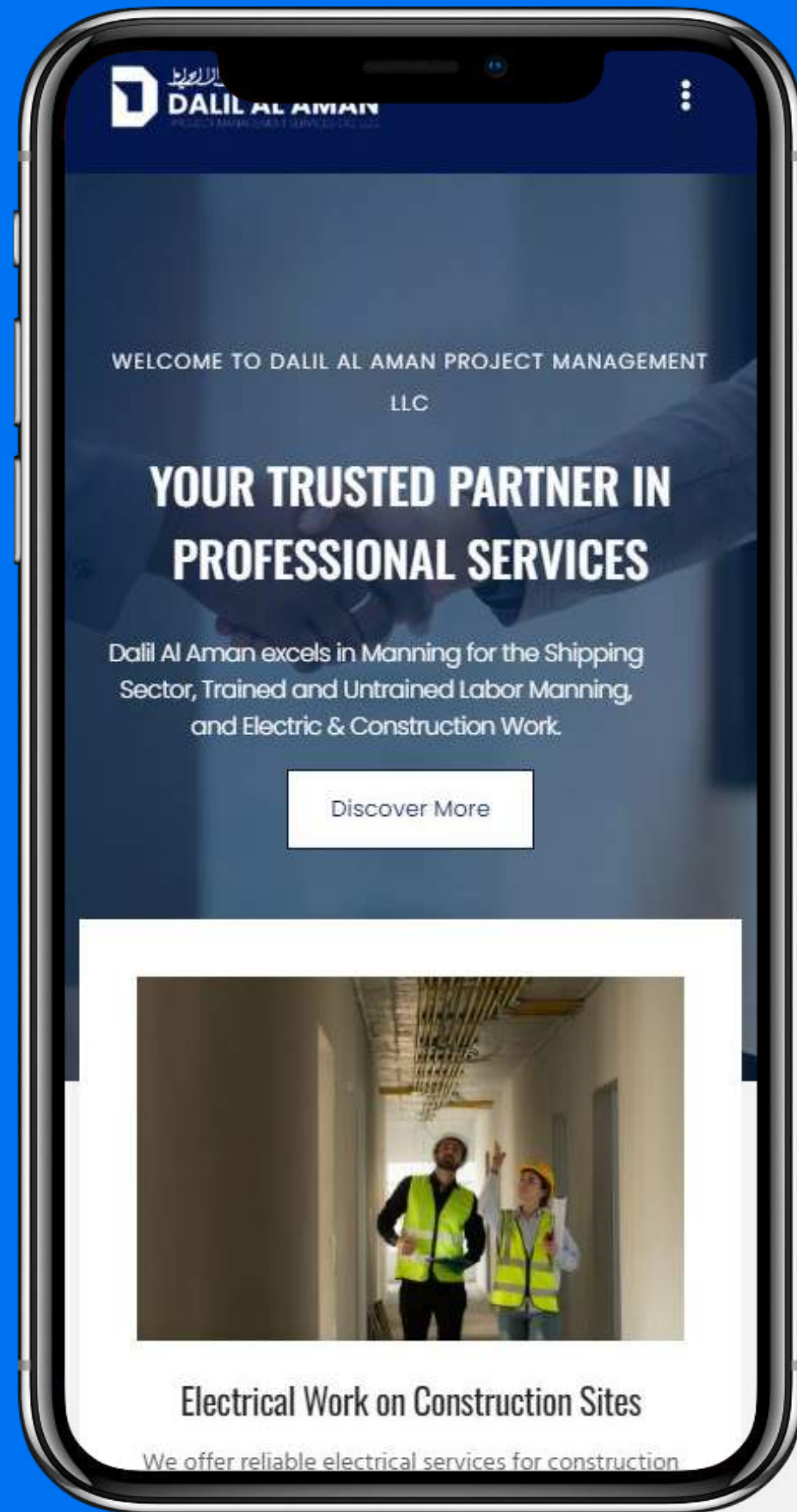
